

Jabach-Medaille

Mit der **Jabach-Medaille** zeichnet die Stadt Köln Persönlichkeiten aus, die sich um die Kölner Museen außerordentliche Verdienste erworben haben.

Die Stiftung der Medaille erfolgte 1966 durch den Rat der Stadt Köln im Gedenken an den kölnischen Sammler und Mäzen Eberhard Jabach. Sie ist nicht dotiert und wird in unregelmäßigen Abständen verliehen.

Vorschlagsberechtigt für die Vergabe der Medaille sind der Oberbürgermeister sowie der Kulturausschuss der Stadt Köln. Die Entscheidung wird von einer Kommission getroffen, die aus dem Oberbürgermeister, dem Vorsitzenden des Kulturausschusses, den ehrenamtlichen Bürgermeistern, dem Kulturdezernenten sowie dem Direktor des beteiligten Museums besteht.[□]

Die Medaille besteht aus Silber, 80 mm im Durchmesser, auf der Vorderseite mit dem Bildnis von Eberhard Jabach und auf der Rückseite das Kölner Wappen mit der Umschrift *MAECENATIBUS GRATA CIVITAS COLONIENSIS*[□]. Sie wurde 1966 von Hans Karl Burgeff entworfen[□].

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.
